**ANNOUNCEMENT ON THE ACCUMULATED NEW BORROWINGS
FOR THE YEAR EXCEEDING 20% OF THE NET ASSETS
AT THE END OF PREVIOUS YEAR**

This announcement is made by China Suntien Green Energy Corporation Limited (the “**Company**”) pursuant to the inside information provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) and Rules 13.09 and 13.10B of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

In accordance with the provision of the Rules Governing the Listing of Stocks on the Shanghai Stock Exchange and other relevant laws and regulations in the PRC, the Company published the “Announcement on the Accumulated New Borrowings for the Year Exceeding 20% of the Net Assets at the End of Previous Year” (“當年累計新增借款超過上年末淨資產的百分之二十公告”) (the “**SSE Announcement**”) on the website of the Shanghai Stock Exchange (<http://www.sse.com.cn>) on 9 October 2020.

As disclosed in the SSE Announcement, the borrowings balance of the Company as at the end of September 2020 was RMB31,677 million, and the annual accumulated new borrowings balance amounted to RMB4,166 million, accounting for 28.17% of the net assets at the end of 2019 of RMB14,791 million.

The breakdown of new borrowings is as follows:
