The board of directors (the "Board") of CHINA SUNTIEN GREEN ENERGY CORPORATION LIMITED (the "Company") hereby announces the key operating data of 2020 third quarter of the Company and its subsidiaries (collectively, the "Group").

#### **NEW ENERGY BUSINESS SEGMENT**

According to the Company's preliminary statistics, the power generation of the Group on a consolidated basis for the 2020 third quarter amounted to 1,641,904.23 MWh, representing an increase of 15.94% over the corresponding period of 2019; the on-grid power generation amounted to 1,481,125.67 MWh, representing an increase of 13.93% over the corresponding period of 2019. As of 30 September 2020, the accumulated power generation amounted to 6,724,953.71 MWh, representing an increase of 7.07% over the corresponding period of 2019; the accumulated on-grid power generation amounted to 6,270,129.36 MWh, representing an increase of 6.29% over the corresponding period of 2019. From January to September 2020, the average on-grid tariff (tax exclusive) of the Company was RMB0.47/KWh, representing an increase of 1.63% over the corresponding period of 2019; the Company's transacted electricity volume in the electricity market amounted to 935,731.20 MWh, the proportion of transacted electricity volume in the electricity market (compared to the power generation in the same period) amounted to 14.92%, representing a decrease of 2.07 percentage points over the corresponding period of 2019.
