The board of directors (the "**Board**") of China Suntien Green Energy Corporation Limited (the "**Company**") hereby announces the key operating data of 2020 fourth quarter of the Company and its subsidiaries (collectively, the "**Group**").

NEW ENERGY BUSINESS SEGMENT

According to the Company's preliminary statistics, the power generation of the Group on a consolidated basis for the 2020 fourth quarter amounted to 3,325,809.38 MWh, representing an increase of 22.49% over the corresponding period of 2019; the on-grid power generation amounted to 3,127,761.05 MWh, representing an increase of 20.11% over the corresponding period of 2019. As of 31 December 2020, the accumulated power generation amounted to 10,050,763.09 MWh, representing an increase of 11.72% over the corresponding period of 2019; the accumulated on-grid power generation amounted to 9,397,890.41 MWh, representing an increase of 10.52% over the corresponding period of 2019. From January to December 2020, the average on-grid tariff (tax exclusive) of the Group was RMB0.47/KWh, representing an increase of 1.71% over the corresponding period of 2019; the accumule to 1,231,577.90 MWh, the proportion of transacted electricity volume in the electricity market (compared to the on-grid power generation in the same period) amounted to 13.10%, representing a decrease of 1.82 percentage points over the corresponding period of 2019.
