The board of directors (the "Board") of China Suntien Green Energy Corporation Limited (the "Company") hereby announces the key operating data of 2024 fourth quarter of the Company and its subsidiaries (collectively, the "Group").

#### **NEW ENERGY BUSINESS SEGMENT**

According to the Company's preliminary statistics, the power generation of the Group on a consolidated basis for the 2024 fourth quarter amounted to 4,285,509.39 MWh, representing an increase of 5.00% over the corresponding period of 2023; the on-grid power generation amounted to 4,184,950.04 MWh, representing an increase of 4.89% over the corresponding period of 2023. As of 31 December 2024, the accumulated power generation amounted to 14,121,880.18 MWh, representing a decrease of 0.93% over the corresponding period of 2023; the accumulated on-grid power generation amounted to 13,782,141.73 MWh, representing a decrease of 1.06% over the corresponding period of 2023. From January to December 2024, the average on-grid tariff (tax exclusive) of the Group was RMB0.43/KWh, representing a decrease of 2.50% over the corresponding period of 2023; the Group's transacted electricity volume in the electricity market amounted to 5,885,412.27 MWh, and the proportion of transacted electricity volume in the electricity market amounted to 42.70%, representing an increase of 0.57 percentage point over the corresponding period of 2023.
